The following is a list of consumer information that Harding University is required by federal regulations to make available to you as a student or parent of a student. This document will give you a brief summary of the information available and at least one source for obtaining a full disclosure of the information.

RIGHTS UNDER THE FAMILY EDUCATION RIGHTS AND PRIVACY ACT (FERPA)

- Right to and procedures for inspecting and reviewing student's education records
- Right to and procedures for requesting amendment of student's education records
- Right to consent to disclosure of personally identifiable information contained in student's education records
- Right to file a complaint with the U.S. Department of Education
- Right to obtain a copy of the student records policy as it relates to FERPA

- Terms and conditions of FFEL loan deferments for service in the Peace Corps, service under the Domestic Volunteer Service Act of 1973, or comparable volunteer service for a tax-exempt organization of demonstrated effectiveness in the field of community service

AVAILABLE FINANCIAL ASSISTANCE

- Description of all available federal, state, local, private, and institutional financial need-based and non-need-based assistance programs, and for each program a description of:
 - Application form and procedures
 - Student eligibility requirements
 - Selection criteria
 - Criteria for determining the amount of a student's award
- Rights and responsibilities of student receiving Title IV and other financial aid, including:

- Criteria for continued eligibility
- Satisfactory academic progress standards and criteria to re-establish eligibility if student fails to maintain satisfactory academic progress
- Methods and frequency of financial aid disbursements
- Terms of any loans received, sample loan repayment schedules, and the necessity for repaying loans
- General conditions and terms applicable to any employment offered as part of student's financial aid award
- Exit counseling information required to be provided for and to be collected from student borrowers of a FFEL or federal Perkins loan

REPORT ON ATHLETIC PROGRAM PARTICIPATION RATES AND FINANCIAL SUPPORT DATA

- Number of male and female full-time undergraduates

- Statistics regarding varsity teams that compete in intercollegiate athletic competitions

- Unduplicated number of students, by gender, who participated on at least one varsity team as of the date of the first scheduled contest

- Institutional revenues derived from and attributable to the University's intercollegiate athletic programs

- Incurred expenses attributable to the University's intercollegiate athletic programs

- Total spent on athletics-related student aid awarded to men and to women

- Aggregate total recruiting expenses for men's teams and for women's teams

- Average annual institutional salary of non-volunteer coaches and assistant coaches (across all sports) of all men's and women's teams on a per person and per full-time basis
